LowCVP Low Carbon Champions Awards

The Low Carbon Vehicle Partnership, Low Carbon Champions Awards are designed to promote examples of outstanding and innovative practice in accelerating the shift to low carbon vehicles and fuels. Through the awards the Partnership hopes to encourage more organisations to actively support our mission of sustainable market transformation to low carbon vehicles.

The Awards will be presented at an Awards Dinner to be held on the evening of 14 July, during the LowCVP Annual Conference (14-15 July) at Twickenham Stadium in west London.

Eligibility

The awards are open to any UK business, organisation or individual that through their actions have made a significant contribution to accelerating the shift to low carbon vehicles and fuels. Both members and non-members of the LowCVP are eligible to apply. International activities are eligible if these were also conducted in, or have directly benefited, the UK.

Awards

There are seven categories for the inaugural Low Carbon Champions Awards reflecting the LowCVP's major programmes of activity:

• Vehicle Manufacturer or Retailer Communications Award:

This award is intended for the manufacturer or retailer that has done the most in the last year to communicate to consumers the benefits of low carbon choices through advertising, marketing, labelling, sales or other activity that promotes the purchase of low carbon vehicles.

• Buses Award:

An award for the company or organisation that has positively influenced the market for low carbon buses through their manufacture, operation or other activity.

• Road Freight Award:

This Award is for the company or organisation that has most positively influenced the manufacture of low carbon commercial vehicles or operation of a low carbon freight fleet. This may be through bringing innovative technology to market or through its enthusiastic and effective adoption. It encompasses both technology and other techniques leading to lower carbon operation.

• Fuels Supplier or Retailer Award:

To be awarded to the organisation that has done the most to bring forward low carbon sustainable fuel technology or the supply of sustainable low carbon fuels into the market.

• Innovation Award:

To be awarded to the SME, start-up, academic or other small organisation or business that has brought forward the most promising technology for reducing vehicle carbon emissions.

• Low Carbon Road Transport Programme Award:

For the organisation running or managing the most effective consumer or business-facing programme to stimulate low carbon vehicle or fuels uptake or more efficient fleet management or driving practices. This includes both publicly and privately funded programmes.

• Special Award:

For the outstanding individual, NGO, community group or academic organisation that has made the greatest contribution to the achievement of the low carbon road transport agenda.

Judging criteria and procedures

The applications will be assessed based upon the quality of the evidence provided against the following criteria:

- The originality or innovation of the work
- Substantive measurable impacts and/or benefits including influence on public opinion or policy
- Any programme of dissemination and promotion of the work
- Participation from a range of stakeholders (including senior management buy-in)
- The commitment of the organisation demonstrated by a sustainable approach and longevity of the work with evidence of continuous improvement
- The replicability of the approach undertaken

In judging the awards consideration will be given to the:

- Scale of the activity relative to that of the organisation and thereby the associated level of risk or commitment
- Clarity and extent of the messages relayed about the activity
- Extent to which the work is part of a wider programme of low carbon activity by the organisation or a one-off activity
- Any relevant legal proceedings or other infringements of requirements in the area in which the award is being judged
- The credibility of the activity with stakeholders and peers.

Entries should be submitted on the form appended to this document. Additional information may be provided where this adds particular value but will be considered at the

judge's discretion. Core information about the nomination should be provided on the application form.

Self-nomination for any of the awards is allowed. The awards are open to both members and non-members of the LowCVP. No preference will be given to members in the judging.

The closing date for nominations is Thursday 24th June 2010
