

# Partnership Activities October - December

This paper provides an update on LowCVP activities during the last three months. It is provided for information only.

The following highlights are identified:

- Director appointed to the Board of the Renewable Fuels Agency and RTFO Carbon & Sustainability Reporting Guidance submitted to Government

The LowCVP Director has been appointed to the Board of the Renewable Fuels Agency (RFA) that will administer the Renewable Transport Fuels Obligation. The appointment is for 2 days per month and will not affect his commitment to the LowCVP.

The Secretariat has also successfully delivered the fourth phase of the work to operationalise sustainability reporting as part of the RTFO. The outcomes of a 12 week Government consultation on draft technical guidance and complementary piloting exercise have been incorporated into a final version of the guidance that has been passed to the DfT and will be provided to the RFA. Subject to sign-off from the RFA Board the final guidance should be issued in December. The remaining phase of the project is to train companies during the roll-out with the scheme commencing in April.

LowCVP has also begun work on the feasibility of establishing a voluntary kitemark scheme for sustainable biofuels. The Partnership has also been involved in a range of activities to increase awareness of biofuels sustainability issues including:

- Providing evidence to the Environmental Audit Committee (verbal and written)
- Addressing the third meeting of the All Party Parliamentary Renewable Transport Fuels Group
- A joint UK/NL/Germany/EC workshop to harmonise GHG calculation methodologies that was only partially successful
- Supporting DfT officials in meetings with the European Commission concerning the Renewable Energy Directive and Fuel Quality Directive
- Party Conference events (as above)

- Participating in US-EU discussions co-ordinated by the International Council on Clean Transportation that include the California Air Resources Board (for the Low Carbon Fuel Standard) and the European Commission
- Providing support for UK delegates in the Global Bioenergy Partnership
- Providing support for a UK/Brazil/South Africa biofuels taskforce meeting

# 2. LowCVP supports successful Waterfront low carbon car conference and Michelin Bibendum Challenge

LowCVP supported the Waterfront Conference Company low carbon car conference on the 7<sup>th</sup> November. The LowCVP Chairman and Director chaired the event throughout. The Secretariat prepared the programme which was headlined by Michael Roberts (CBI) who spoke about the recent Integrated Transport Commission (CfIT) report on road transport and climate change and Professor Julia King's interim report on low carbon cars. Prof King's speech received extensive media coverage in the days following the event including a front-page article in The Times. The conference received positive feedback from an audience of over 60 delegates.

LowCVP also supported the recent Michelin Bibendum Challenge in Shanghai. At the invitation of Michelin the LowCVP Director participated at the event including an expert round-table on biofuels.

#### 3. LowCVP guides the development of Public Procurement Programme

The Partnership provided extensive input to the DfT's low carbon vehicle public procurement initiative that was announced in November. LowCVP responded to the consultation and attended a technical seminar run by DfT on detailed design issues and priorities. The Secretariat has followed up with bilateral discussions and a letter detailing the wish to see the programme make use of a forward commitment mechanism to maximise the programme's effectiveness. The DfT has recognised and reflected some the Partnership's concerns in the recent announcement that the programme would focus on vans.

The Bus Working Group has also been assessing the potential for the use of public procurement in the bus market in the UK which has been hitherto problematic. A feasibility study is underway that will be completed by April 2008 and it is anticipated will inform a second phase of the programme in due course.

#### 4. LowCVP provides evidence to EAC labelling inquiry

LowCVP has provided a memorandum to the Environmental Audit Committee (EAC) as part of its inquiry into environmental labelling. The submission provided background on the design and implementation issues affecting adoption of the new car efficiency label agreement which was brokered by LowCVP. The paper also described the outcomes of recent surveys on deployment of the label, dealer attitudes, public awareness and impact. The LowCVP also gave verbal evidence to the Committee's inquiry on this matter in January 2008 in conjunction with the SMMT.

# 9.1 Bus Working Group

The Bus Working Group met on the 15<sup>th</sup> November. The meeting discussed:

# 9.3 Innovation Working Group

- Engaging with Investors EST updated the Group on plans for an investor event in the autumn and provided feedback on a successful Investor Roundtable Debate held in May. There was a presentation of the marketing plan behind the newly launched Clean Tech Magazine.

Geoff Callow retired as Chair of the Innovation Working Group and will be replaced by Dave Greenwood of Ricardo at the next meeting.
