

Partnership Activities June - November

1 Members to own LowCVP

The LowCVP Board has approved the creation of LowCVP as a not for profit company to be owned by its members. The aim is to establish the new company early in 2009 and apply for charitable status. New operating arrangements will be fully implemented by April.

Membership of the new company will be open to any existing member or other organisation that meets the LowCVP's membership criteria and contributes by paying an annual membership fee or making an equivalent in-kind contribution (that offsets costs that would otherwise be incurred by LowCVP).

Members will own LowCVP enabling them to elect Directors to the Board, participate in a Council of Members (that will replace the Steering Group) and receive a series of other benefits. All current members will be expected to join LowCVP by April 2010 in order to continue to engage in the Partnership's activities.

Further information on the changes is available in a paper IWG-P-08-26 to be discussed at the working group meeting.

2 LowCVP hosts successful 5th Annual Conference

The LowCVP's 5th annual conference took place on 23 July, on 'VIP Day' of the London Motor Show at ExCel, London. 164 delegates attended the event, which was

followed by a reception in the Motor Show's 'Greener Driving Pavilion' (in which the LowCVP was a collaborator).

Delegate feedback following the event was excellent with over 90% describing the event as 'very good' or 'good.' Over 80% also described the event as 'very good' or 'good' value for money.

LowCVP generated a surplus from the conference of around £10k which will be used to support the work programme.

3 Changes within the Secretariat

The Low Carbon Vehicle Partnership has appointed Chris Brown as the Stakeholder Relations Manager to extend the reach of the Department for Transport's ACT ON CO₂ campaign.

Chris will work with organisations across the broad automotive sector including motoring and consumer groups to raise awareness of the campaign and develop and implement practical initiatives with stakeholders to encourage the purchase of low carbon vehicles and promote eco-driving. Chris has worked as a communications consultant in various transport-related sectors, including major car manufacturers, a transport fuel trade association and the Institute of Advanced Motorists.

Jessica Chalmers will leave LowCVP after two years in mid-October. She is taking up a role with Winrock International where she will be working to encourage the sustainable development of bioenergy. Her position in the Secretariat will be taken by Roy Williamson in mid-November.

4 Successful collaboration at Climate Clinic during party conferences

The LowCVP collaborated with 21 other organisations to host the Climate Clinic; a dedicated space for fringe discussions on issues relating to climate change at each of the party conferences. The conferences took place during the second half of September.

The LowCVP co-hosted (with WWF and the Campaign for Better Transport) a fringe meeting at each of the conferences on the theme of transport in an oil and climate-constrained World. The event at the Labour Conference (chaired by Greg Archer) was particularly well attended and included the Transport Secretary on the speaker panel. 5 European COMPRO project adopt LowCVP low carbon bus procurement specification

The LowCVP in conjunction with bus operators, manufacturers and PTAs have developed an operational requirements specification for a low carbon bus as part of a feasibility study into forming a consortium to procure low carbon buses in the UK outside London. The Secretariat has been seeking to promote the use of this specification with European partners and in March we joined the Procurement Managent Group of the COMPRO project, a consortium of Italian, French, German and Swedish cities intending to procure environmental buses.

The COMPRO project members, at their latest meeting in September, have voted to adopt the LowCVP specification as the basis for their procurement, which is now being developed into a full specification for the group. The Secretariat are now seeking to ensure UK bus manufacturers have full exposure to the project and are seeking to bring the project to the Euro Bus Expo in Birmingham in November.

6 Advertising survey shows shift in advertising to low carbon vehicles

A LowCVP survey of newspaper and television advertising has found that the motor industry has shifted advertising spending towards more fuel efficient cars.

During 2007, the proportion of advertising spending on the most efficient vehicles (in VED bands A, B and C) doubled from 20% to 40% of total spending. By contrast, advertising expenditure on larger and less efficient cars in VED bands E and F fell by half. Advertising spending on the most inefficient VED Band G vehicles remained around 20% of the total.

However, overall advertising spending continues to be biased in favour of higher emitting vehicles. In 2007, 52% of car advertising expenditure was focused on vehicles in VED Bands E, F and G, which represent just 37% of total registrations. The survey found a disproportionate advertising expenditure on 4x4 (multi-purpose) vehicles - 20% of total advertising spending - compared to the 7% of sales volume represented by this market segment. The survey is based upon analysis of data by Thompson Intermedia of all car adverts in the national press and TV throughout 2007.

The survey also found that 12% of advertising messages now relate to fuel consumption and/or the climate change impact of cars.

7 91% of new car dealers now display energy efficiency label

A LowCVP survey of car dealerships has found 82% of new cars on display are now correctly labelled, up from 65% in 2007. In total, 91% of car dealerships now use the label (86% in 2007).

A mystery shopping exercise has also found car dealers are now making better use of the label when discussing vehicle options with car buyers. Over 75% of dealers surveyed made use of the label in conversations with customers. 61% of dealerships

made reference to the financial savings illustrated by the label, while 33% introduced the issue of climate change.

8 Director completes secondment to Renewable Fuels Agency to coauthor Gallagher Review

The Director has completed his work as a co-author of the Gallagher Review for the Renewable Fuels Agency (RFA). He was asked to support the review by the DfT following LowCVP's work in the development of biofuels sustainability and in his capacity as a member of the Board of the RFA.

The Review, requested by Ruth Kelly in February, examined the indirect effects of biofuels. It concluded that displaced land use change could eliminate any greenhouse gas benefits from biofuels that also contribute to rising prices for some food commodities. It recommended a slowdown in the introduction of biofuels until effective controls were established to address displacement effects.

In a Statement to Parliament in July, the Secretary of State confirmed the Government accepted the findings and recommendations and would be consulting on revisions to the RTFO. The Director has subsequently been involved in disseminating the findings of the Review, particularly in Europe where he has attended a series of meeting with the Commission and MEPs amongst others.

9 Move to new offices successfully completed

In May the Secretariat moved to new offices after the landlord (the French Chamber of Commerce in Great Britain) released the tenancy. It was tough in the heat as we couldn't open the windows or use the air conditioning. Switching off the engine and getting Jon to push the car through the jam along Piccadilly proved to be crucial!"
