# Activity Report July- October 2009

### Activity Highlights:

- 1. Record levels of dealers displaying car label as scheme is extended into the second-hand market

A survey conducted for the LowCVP has shown the new car fuel economy label's utilisation, already at a high level, is continuing to grow. The LowCVP car dealer survey conducted in June indicated that 94% of dealerships have adopted the new car label, up 3% on last year, with 88% of cars surveyed displaying the label and 81% of dealerships achieving the good performance target. Twenty car brands have now achieved the target level of performance, along with 116 of the 185 dealer groups surveyed. The survey follows one of consumer awareness that found 54% of car buyers are now aware of the new car fuel economy label over 50% for the first time.

LowCVP has also announced the labels will be extended into the nearly new market. A voluntary initiative developed by LowCVP with support from RMIF, SMMT and DfT will be launched to consumers on the 2<sup>nd</sup> November with Transport Minister Sadiq Khan. As at mid-September, over 800 dealers had signed-up to the scheme.

#### 2. LowCVP promotes Green Bus Fund at Bus and Coach show

LowCVP have been actively supporting the DfT's roll-out of the Green Bus Fund, notably assisting with the design of the purchase support fund and developing the testing and accreditation procedures. A dedicated area on the LowCVP website has also been launched to provide support and advice on low carbon buses. The microsite provides bus operators, manufacturers and local transport authorities with the resources to assess, plan and implement the roll out of low carbon buses and provides links to all important key documents relating to accreditation of LCEBs, claiming the LCEB incentive and bidding for Green Bus Funds.

The LowCVP also exhibited at the Coach and Bus Live show at the NEC on the 8<sup>th</sup> and 9<sup>th</sup> October, promoting LCEBs and the Green Bus Fund. At the show Jonathan Murray and Helen Pritchard, Head of Bus Subsidy Team at DfT, ran seminars answering questions for delegates which proved very successful.

### 3. LowCVP presses Treasury to retain duty break for high blend biofuels

LowCVP Director and Vice-Chairman Darran Messem met with the Exchequer Secretary to the Treasury, Sarah, McCarthy-Fry in the run up to the Pre-Budget Report. The meeting, held at the request of the Treasury, was also attended by the Renewable Energy Association and UK Sustainable Biodiesel Alliance. The discussion focused on the impact of ending the duty break, in April, on the niche market for high blend biofuels. LowCVP explained that to meet the Renewable Energy Directive Target of 10% by 2020, high blend vehicles may be required as blending limits are reached for conventional vehicles. To close down the market now would be premature, particularly since GHG-savings could be significant and new mandatory sustainability criteria are imminent along with proposals to quantify and/or account for indirect effects. Other representatives commented on the potential harm to the market, particularly small biofuel suppliers. The Treasury listened without any commitment but LowCVP Managing Director believes there is now an even chance of some flexibility in the PBR.

LowCVP also took the opportunity to highlight recent work showing the potential for biomethane articulated HGVs and stressing the need for Treasury and DfT to look for opportunities to reduce freight emissions. LowCVP also reminded the Treasury of the need to continue to strengthen signals to encourage the purchase of low carbon cars in fleet and private markets.

#### 4. LowCVP gives evidence to DECC Select Committee

Managing Director Greg Archer gave evidence to the Department of Energy & Climate Change inquiry *Low Carbon Technologies in a Green Economy* in October. Also giving evidence was Prof. Julia King. The wide ranging discussion considered:

- The effectiveness of the green stimulus package in encouraging low carbon vehicle and fuels
- The potential of low carbon technologies
- Adequacy of current policy and support
- How to change consumer attitudes
- The potential role of biofuels
- The need for integrated transport policy and demand management measures.

#### 5. Low Carbon Automotive Directory published

LowCVP has supported the development of a new guide to organisations engaged in the research, development and supply of low carbon vehicle and fuel technologies. The Low Carbon Automotive Directory, compiled by the LowCVP and produced by UKTI provides information on the capabilities of a range of UK companies and organisations involved in the low carbon automotive sector. # 6. LowCVP joins Cenex

LowCVP has formally joined Cenex as a member following its incorporation in April. The Partnership has been involved with Cenex since it was originally proposed by the 1<sup>st</sup> Automotive Innovation and Growth Team. The LowCVP Innovation Working Group undertook work to develop the AIGT proposals into a draft initial work programme and objectives. The LowCVP Director chaired the Steering Group which oversaw the setup of Cenex for BERR and was appointed as a Director in an individual capacity, since LowCVP had no legal structure.

With the incorporation of LowCVP, the Board approved an approach Cenex to become a member that was approved at a recent Cenex Board meeting. The change is largely an administrative one formalising the current arrangements through which LowCVP engages through the Managing Director in his personal capacity.

# 7. Managing Director chairs Economist low carbon vehicle debate

LowCVP Managing Director chaired an entertaining and informative debate organised by *The Economist* with the Support of Shell in September. With participants of diverse backgrounds: Julia King, Aston University, Doug Parr, Greenpeace, Ken Keir, Honda, Graeme Sweeney, Shell, Tom Standage, The Economist and Michael Hurwitz, DFT. The event provoked fierce but friendly debate on the respective rolls of biofuels, hydrogen, electric vehicles and hybrids. The Board met on 15<sup>th</sup> September and addressed:

#### Members Council

The Members Council met on 22 October at the offices of SMMT. The following substantive issues were addressed:

- A report was provided on the Board meeting of the 15<sup>th</sup> September.
- A membership discount of 50% has been approved by the Board for those members who have yet to become owner-members.
- Six posts on the LowCVP will come up for re-election this year. Voting is restricted to ownermembers.
- Initial thoughts were set out for the development of the LowCVP Strategy to 2013 along with a timetable for developing the strategy and work programme for 2010-11 with members input.
- Notable work programme items were highlighted including
  - The announcement of the Green Bus Fund by DfT which the BWG has provided close support to DfT
  - The successful trade launch of the Used Car Label in July and registration of more than 800 dealers during the summer.
  - Progress with the Technology Challenge, with 17 submissions received and 6 successful entries being selected for the short list.
  - Car dealer survey completed showing 94% of car showrooms have now adopted the new car label.
  - LowCVP responded to the European Commission on policy options for managing indirect land use change from biofuels
  - Biofuels C-linkage initial recommendations have received a positive reaction from the Department which are basing their initial proposal on these.
  - Proposed amendments to the work programme were confirmed, including:
    - The establishment of a Local authority Low Carbon Vehicle and Fuel Network to provide a focal point for local government involvement in LowCVP was approved.
    - The commencement of a new project in response to the DfT strategy "Low Carbon Transport: A Greener Future" was reported
    - An amendment to the project evaluation of low carbon programmes was agreed in response to the establishment of the Office for Low Emission Vehicles by Government was agreed.
- At the request of the DfT the LowCVP will reactivate its work in relation to Heavy Commercial Vehicles
- A new Challenge was announced to focus on community activity to encourage the uptake of low carbon vehicle and fuels.
- Membership of 13 organisations was confirmed
- The meeting schedule for the coming year was announced
