Activity Report (February-April 2010)

This paper summarises key activities since the last BWG meeting, 2nd February. It is provided for information only

The following highlights are identified:

- 1. Over 300 attend LowCVP seminars as part of Sustainabilitylive!
- 2. Successful investors event draws 80 attendees
- 3. Budget announcements demonstrate on-going LowCVP influence and effectiveness
- 4. LowCVP hosts seminar on electric vehicles at BASE conference and highlights opportunities at major utilities conference
- 5. MD chairs major biofuels seminar

Also of note:

- 1. MD presented to National Association of Councillors climate workshop in York encouraging greater action from local authorities to promote low carbon vehicle and fuel technologies. The Secretariat also met with the Local Government Association to help take this forward.
- 2. The MD participated in a well attended RAC Foundation event on low carbon vehicles. His opening remarks focused on the need to support a portfolio of technologies and provide adequate incentives to support low carbon vehicles and fuels before being quizzed by a panel of experts and taking audience questions.
- 3. The MD met with Conservative Transport and Climate teams to make them aware of the Partnership and offer support in taking forward their policies and programmes in the event they are elected on May 6th.
- 4. Membership has grown from 135 to 152.
- 5. The MD is helping steer Commission for Integrated Transport (CFIT) project on medium length journeys. The Deputy Director has been invited to present the findings of LowCVP work on low carbon vans as input to another CFIT project.
- 6. The Deputy Director has been invited to join an Energy Technologies Institute Steering Group on HGVs.
- 7. LowCVP's on-line seminar programme has continued to gather pace with events to date on electric vehicles, green buses, consumer attitudes to low carbon vehicles, freight emissions vans and CO2 information on car makers' websites. We also held a webinar attended by 40 on the LowCVP And its achievements and future plans. All webinars are recorded and can be viewed at any time via links on the LowCVP website. Future webinars are scheduled.
- 8. The MD has judged the Shell Springboard and Rushlight Awards. Successful automotive companies included: Aeristech, Nexeon and Hardstaff Group.

LowCVP 2010 meetings:

1. Over 300 attend LowCVP seminars as part of Sustainabilitylive!

As part of the major trade show Sustainabilitylive! LowCVP hosted a series of seven, 35 minute seminars on greening transport. The sessions covered topics ranging from greening fleets, greener business travel, smarter driving, electric vehicles, better freight transport and mobility without owning cars. In one session the MD interviewed Prof. Julia King of the Climate Change Committee exploring "how we can achieve our transport emissions reduction targets." In total around 350 attended the sessions that were well received.

2. Successful investors event draws 80 attendees

LowCVP hosted a successful seminar with prospective investors in low carbon automotive technology in London on the 23rd March. Supported and promoted by The EIC Environmental Investment Network and Cleantech Magazine the event was attended by 88 delegates and designed to:

- address uncertainty within the finance community regarding the low carbon automotive sector
- deliver to investors a clearer picture of the direction of the automotive sector and how low carbon technology options compare; and
- provide an important networking opportunity for UK cleantech automotive SME's to network with potential investors.

85% of respondents described the presentations as "very" or "somewhat" useful. Nine respondents also expressed interest in joining LowCVP. The free to attend event cost LowCVP about £5,500.

3. Budget announcements demonstrate on-going influence and effectiveness

Three budget announcements highlighted the on-going influence and effectiveness of LowCVP. The announcements included:

- £3.5M to support the increased use of biomethane, produced from waste material, for transport – subject to a feasibility study. LowCVP work in 2009 highlighted the excellent opportunities from biomethane and outlined the scope of a demonstration activity that stimulated the bid for funding. LowCVP is currently supporting the feasibility study.
- £3.5M allocated to support low carbon commercial vehicle technologies subject to a feasibility study. LowCVP has been pressing for progress on developing the market for low carbon HGVs for several years and is presently leading a major DfT study to define low carbon trucks.
- £10M for a further Green Bus Fund call. LowCVP designed the criteria defining a green bus and supported the roll-out of the original £30M call that was over-subscribed.

4. LowCVP hosts a seminar on electric vehicles at BASE and highlights opportunities at major utilities conference

LowCVP hosted a seminar as one of the conference modules within a major new event focused on sustainable business - Business and a Sustainable Environment: base 2010. BASE was held at on March 16-17 at ExCel London. The seminar focused on the practical applications for electric vehicles and was well attended and received attracting around 50 delegates. As part of the arrangement 20 free places were provided to LowCVP members.

The MD also spoke at the Smart Utilities Forum, a major utilities conference on the subject of electric vehicles. The presentation, available through the LowCVP website, outlined both the opportunities and challenges of the shift to EVs emphasising that increasing electrification would happen, but not overnight, and should not be viewed as a silver bullet solution.

5. MD Chairs major biofuels seminar

The MD chaired a one-day seminar on biofuel sustainability, certification and indirect land use change as part of the World Biofuels Congress in Amsterdam in March. The event, the largest of its type in Europe, was attended by over 1000 delegates with the seminar attracting over 100 with standing room only. It was the third occasion LowCVP had been asked to support the event indicating the high standing and international reach of the Partnership's work.
